NOTIFICATION OF DELAYED DELIVERY DATE OR IN-TRANSIT MILEAGE ACCUMULATION

Use this form to notify Ford Motor Company of a delayed warranty start date or to report in-transit mileage accumulation on a vehicle driven (not transported) from the assembly plant to the selling Dealer. Retailers should be sure to notify customers of the correct warranty start date and starting miles. Ford may request copies of each bill of sale and in-transit delivery document to verify the information provided on this form.

DELAYED DELIVERY DATE OR IN-TRANSIT MILEAGE ACCUMULATION PROGRAM

The new vehicle limited warranty coverage on a Ford Motor Company vehicle begins when a Ford, Lincoln or Mercury Dealer sells the vehicle to an individual or to an organization. This sale date becomes the warranty start date, which is the date when the new vehicle limited warranty begins. In some special cases, the vehicle's original warranty start date and/or warranty start mileage may need to be updated. This is referred to as a "Delayed Warranty Start Date and/or In-Transit Mileage Accumulation" warranty coverage extension. Updating the vehicle's warranty start information will ensure the owner receives the full benefit of their new vehicle's limited warranty. Requests for a warranty coverage extension for an individual vehicle may be made if a new vehicle was:

- ⊙ Purchased from a body manufacturer, special equipment company or their retailers and not a Ford/Lincoln/Mercury Dealer.
- ⊙ Not put into service (i.e., not driven) after it was purchased due to the installation of a special body or equipment. **NOTE:** Use of a converted vehicle as a demonstrator, driving a converted vehicle to one or more shows, or driving a converted vehicle from one retail sales lot to another retail sales lot constitutes placing the vehicle into service.
- ⊙ Driven (not transported) from assembly plants to Dealers or to body companies and then to Dealers or retailers before final delivery to the first retail owner.

DETERMINING THE WARRANTY START DATE

A vehicle's warranty start date is either the date when the vehicle was sold to the first retail purchaser **OR** the date when the vehicle was first put into service (i.e., used as a demonstrator or transported to dealer shows).

DETERMINING THE WARRANTY STARTING MILES (IN-TRANSIT MILEAGE ACCUMULATION)

The vehicle's mileage warranty coverage begins at zero miles. Occasionally, before the first retail purchaser takes delivery of a new vehicle, the vehicle has been driven (not transported) from assembly plants to Dealers or to body companies and then to Dealers or retailers. The mileage accumulated on the vehicle during this time is referred to as "in-transit mileage." To ensure that the vehicle owner receives the full benefit of their new vehicle's limited warranty, the mileage warranty coverage may be extended to compensate for the accumulated in-transit miles. The requested mileage warranty extension must equal the actual number of in-transit miles accumulated on the vehicle up to a maximum of 4,000 miles. Ford Motor Company reserves the right to deny requests for a warranty coverage extension.

It is important to note that the mileage accrued on vehicles during customer demonstrations, use as a rental vehicle, transportation to shows or to other events, or from lot-to-lot transfer does not qualify as "in-transit mileage" and therefore **CANNOT BE INCLUDED** in the request for a mileage warranty coverage extension. Only the actual miles accumulated on vehicles when driven from a manufacturer/body company to a Dealer/retailer can be included.

WHEN YOU CAN EXPECT TO SEE AN UPDATE IN THE FORD SYSTEM

Warranty start dates are updated in the Ford system according to the model year of the vehicle. Current model year vehicles are those that are within three (3) model years old. These vehicles are updated in the system nightly, and updates will appear as quickly as the supplier can process them. Vehicles older than three (3) model years are updated in the system once per month on the last day of the month. The system update will vary based on the date the WSD Headquarters received the request. See the schedule below to help you determine when you will see an update on your individual request.

Model Year (Age) of Vehicle	Request Received at WSD Headquarters*	Earliest the Update Will Appear in the Ford System
Within Three (3) Model Years	Any Day of the Month	Within Ten (10) Days After WSD Headquarters Received the Form
Older Than Three (3) Model Years	1 st thru 15 th Day of the Month	On the first business day of the following month
Older Than Three (3) Model Years	16 th thru Last Day of the Month	On the first business day of the second month

* It takes approximately ten (10) business days from the time the form is mailed before WSD Headquarters receives the form. For faster processing, submit requests online at www.fordwsd.com for eligible vehicles.


