

The Leisure Days RV Group Rental Motorhome Giveaway

Rules & Regulations - April 17th - May 21st, 2023

1. Eligibility: The Leisure Days RV Group Rental Motorhome Giveaway is open to legal residents of Canada who sign up any Leisure Days RV Group location. Entrants must be **25 years of age or older** as of their date of entry in this promotion in order to qualify. This giveaway is subject to provincial, and local laws and regulations and void where prohibited by law. Leisure Days RV Group employees, its subsidiaries, affiliates, suppliers, partners, advertising and promotion agencies, and directors (collectively the "Employees"), as well as members of an Employees' immediate family and/or those living in the same household of Employees are ineligible to participate in the Rental Motorhome Giveaway. Winners must provide a copy of their current VALID automobile insurance.
