## Border Closure / Inactive Information

With the border closure extended, we have made some changes to our inactive contract for our Canadian guests affected by the closure.

- Waiving the 5 year eligibility requirement
- Waiving the 1 time inactive stipulation
- Waiving the May 1st deadline for going on inactive status. We need to know now so we can make all of the necessary arrangements.
- We need the agreement signed in order to proceed. This can be as simple as taking a photo and texting to 518-563-1983 or via e-mail at campground@momot.com and returned with any payment due.
- Making Payments - We are set up to receive your payments using any of the following:
  - Mail - simply mail a check or Money Order in US funds to Plattsburgh RV Store, 240 Tom Miller Road, Plattsburgh, NY 12901
  - Contactless Via phone - simply call us at either 518-563-1983 or 518-594-3873 to make your payment.

Before considering inactive status as an option, please read all of the bulleted lines on the Inactive Agreement. Your account must be current and 1/2 of your contract paid in order to qualify.

## Expectations

While this may seem like a big waiting game for a lot of you, rest assured that with patience and understanding, we will get through this. We must comply with the guidance of our governing agencies. Although New York is now in Phase One of reopening, nothing has changed for campground regulations. # INACTIVE CONTRACT AGREEMENT

Due to the Covid-19 situation, we understand that you have requested to go inactive for the 2020 season.

As a courtesy to help you during this time of global crisis, we have modified our Inactive agreement to better serve our affected guests. ~~If you decide to take a break we offer an inactive contract. This is a courtesy to help you decide weather or not you would like to continue.~~

- ~~If a site has been occupied by the same tenant with the same unit for five consecutive seasons, it qualifies for an inactive contract for only one season. **WAIVED DUE TO COVID-19**~~
- The camper can be left on site and is not to be used by anyone. If unit is used even for 1 day, the full contracted rate will be due in full.
- Your camper cannot be connected to water or electricity.
- Tenant must pay 1/2 of the seasonal contract ~~by May 1st. After May 1st standard rates apply.~~ now, or standard rates will apply. **(CHANGED DUE TO COVID-19)**
- Your account must be in good standing, with all other invoices paid in full.
- The site will be shown as vacant site and if Blue Haven has the chance to rent the site for a complete season, the inactive tenant will have the choice of paying the balance of the contract or surrender the site.
- If the site is surrendered, site clean up and unit removal is the customers responsibility. Inactive tenants will have 14 days to vacate site.
- For Sale sign's on or in your trailer are forbidden.
- Blue Haven will mow your lawn.
- Blue Haven is not responsible for the security of any property.
- Liability, Gunboat Rock Campsite, Inc. DBA Blue Haven Campground is not responsible for any personal injuries, damage, loss or theft of personal property sustained by any guest, visitor, residents; registered or not; in or on any campground facilities or grounds.
